CONTEXT

Biographical/Administrative History: Fred Emery was born in Essex and attended Bancroft's School. He became a foreign correspondent and, amongst many assignments, he covered the Vietnam War. Fred Emery worked for The Times and was its chief Washington correspondent for seven years during the Watergate era. He later presented Panorama on BBC television.

Brian Lapping Associates was formed by Brian Lapping and Norma Percy in 1988, and is a London-based television production company specialising in documentaries. Watergate was a joint production with the BBC and the Discovery Channel, produced by Norma Percy and broadcast in the UK and the USA in June and August 1994.

CONTENT

Scope and Content: Includes transcripts and notes of interviews with Watergate protagonists; Watergate television series (1994) correspondence, scripts, notes; drafts of "Watergate: the corruption of American politics and the fall of Richard Nixon" (Jonathan Cape, 1994), research correspondence, publicity.
